One member of the public was present for item 19/01579/FULLS, Land at Ganger Wood, Straight Mile.

### **Declarations of Interest**

The Chairman asked Members if they had a pecuniary, or personal, interest in the applications to be considered. Chris Ling declared a personal interest in application 19/01579/FULLS, Land at Ganger Wood as he shared a short boundary with a small section of the woodland that the proposed entrance was intended to serve. He stayed in the room and voted.

### **Application 19/01579/FULLS Land at Ganger Wood**

It was noted that there had been several previous attempts to create an access in this area. A type of stock fence was now in position. The service road was owned and maintained by Hampshire County Council who had had to reinstate the ditch and bank several times after it had sustained damaged. The Chairman adjourned the meeting for 5 minutes and invited the public to speak. It had been a condition of the building of a dwelling on the site of the old petrol station 26 years ago that there would be no direct access to the Straight Mile from the site. As volumes of traffic had increased considerably on the A3090 since then it seemed inappropriate that any direct access be allowed now. The woodland was protected by preservation orders and there was concern that any development would harm the trees. Members considered the application and voted unanimously to object.

### **Other Matters**

The next Planning meeting had already been fixed as 29<sup>th</sup> July 2019.

There were no other matters to note.
