 - a. 21/00858/TPOS; Tree works as per schedule received; Woodlands 56 Beechwood Close Chandlers Ford SO53 5PB. Comment: "We are content to rely on the opinion of the tree officer."
 - b. 21/00704/VARS; Vary condition 02 of 19/02114/FULLS (First floor extension to provide 2 additional ensuite bedrooms; single storey side/rear extensions to provide extended living accommodation; new dropped kerb to Beechwood Crescent (Amended scheme)) to allow addition of 3 rooflights; 12 Beechwood Crescent Chandlers Ford Eastleigh Hampshire SO53 5P. Comment: "No objection."
 - c. 21/00703/CLPS; Application for a Lawful Development Certificate for a Proposed Erection of detached garden studio room built on concrete hard standing base 2m away from the boundary line; Churchfield House Knapp Lane Ampfield SO51 9BT. Comment: "Objection". Reasons: "We object because permitted development rights have been removed for this site: we raised the issue of permitted development rights under application reference 13/01289/FULLS, and they were removed by Test Valley Borough Council."
